Subject: Fixation of 5% quota over and above the allowed intake by PEC for Government nominated seats including religious minorities

Dear Sir/ Madam

It is to apprise that PEC Governing Body in its 40<sup>th</sup> meeting held on February 10, 2021, deliberated on Article -2A(2) of PEC Regulations of Engineering Education in Pakistan, and the amendment made is as under;

*"5% seats over and above the allowed intake for government nominees including religious minorities in Public Sector universities/ Institutions subject to approval from PEC. If HEIs desire to admit more students, then may apply for change of scope (increase in intake) to ensure the quality and standards."*

2. In the light of above decision, 5% seats per program for government nominees including religious minorities, to be considered over and above the allowed intake of Public Sector Universities/ Institutions, while fulfilling admission requirements and qualifying entry test **(Copy of SRO is enclosed herewith).**

**NOTIFICATION**

*Islamabad, the 3rd June, 2021*

**S. R. O. 778(I)/2021.**— In exercise of the powers conferred by Section 25A of the Pakistan Engineering Council Act, 1975 (V of 1976), the Governing Body of the Pakistan Engineering Council, in consultation with the Committee of Vice-Chancellors of the Universities of Engineering and Technology of Pakistan, is pleased to direct that the following further amendments shall be made in the Pakistan Engineering Council Regulations for Engineering Education in Pakistan, 1985, namely:—

In the aforesaid Regulations, —

- (1) in Article 2A, in clause (2), before the existing proviso, following shall be substituted, namely:—

“All reserved seats/quotas shall be upto the extent of 5% over and above the maximum allowable intake per yearly session approved by the Council for an engineering program of the public sector institution/ university.”
