Subject: Standard Adjustment on Unprecedented Price Hike of Construction Machinery and Construction Materials


Please refer to PEC letter No. PEC/Const/Misc/2022 dated February 28, 2022 on the subject matter. It is to apprise that Pakistan Engineering Council (PEC) in consultation with relevant stake holders is putting in efforts to formulate workable solution for the problem caused by recent unprecedented price hike in construction inputs with its adverse effects on the Construction firms and eventually the on-going projects.

2. It is further informed that PEC in collaboration and under the guidance of Planning Commission of Pakistan, has formulated and promulgated Price Adjustment document "Standard Procedure and Formula for Price Adjustment (Second Edition) May 2022", which is available at PEC website (https://pec.org.pk/wp-content/uploads/2022/07/STANDARD-PROCEDURE-FOR-PRICE-ADJUSTMENT_new.pdf). This document is applicable to all future projects, yet with a solution in general terms, for ongoing projects as well.

3. The more precise, elaborate and discernable mechanism for Price Adjustments applicable to ongoing stalling projects is under deliberation. It will be finalized shortly for issuance to all concerned through Planning Commission.

4. Above in view, it will be prudent that no default, liquidated damages or any other punitive clause of the Conditions of the Contract be invoked against any Consultant / Constructor / Operator till the time a revised price adjustment policy is approved and notified.
