Dear Sir/ Madam,

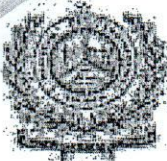
1. I am directed to inform that the cut-off-date for submission of SAR as per PEC Policy is October 31 of each year for the graduating batch in the succeeding year. Further, in case of non-compliance, late fee charges on delayed submission of SAR would be applicable (Rs.100,000 for each month after October of submission year as prescribed in Sr# 3 of above mentioned letter and amounting to maximum penalty of Rs.500,000 till March of the graduating year). The request may not be entertained after the March of the graduating year of batch required accreditation.

Subject: Cut-off-date for Various Accreditation Visits and Late Fee Charges

1. The subject matter was placed in PEC 93rd EAB/EA&QEC meeting held on September 5, 2019 at PEC Head Office, Islamabad under agenda Item No.07(a & b) and the decision taken by the Committee is reproduced below:-

| S# | Visit Type | Cut-off-Date |
|----|--|---|
| 1. | Launching a new program through Zero Visit | January 31 of the same year. |
| 2. | Interim Visit | Before the end of 4 th Semester of first approved intake. |
| 3. | Accreditation / Re-Accreditation Visit | By October of each year for the graduating batch in the succeeding year. |
| 4. | Change of Scope Visit | By March of the same year in which changes are required to be implemented in the program. |

2. However, regarding monthly course/slab of late fee charges on delayed submission of SAR, One Hundred Thousand (Rs.100,000/-) as late fee for each month after October of submission year (as prescribed in Srf# 3 of the table above) till March of the graduating year, amounting to maximum penalty of Rupees Five Hundred Thousand (Rs.500,000/-). The request may not be entertained after the March of the graduating year of batch required accreditation. Moreover, for visit types mentioned in Srf# 1, 2 & 4, double fee will be charged on delayed submission after cut-off-date subject to approval of the competent authority to execute visits as special case.
