NOTIFICATION

Islamabad, the 26th July, 2023

S. R. O. 1187(1)/2023.—In exercise of the powers conferred by section 25 of the Pakistan Engineering Council Act, 1975 (V of 1976), the Governing Body with the previous sanction of the Federal Government, is pleased to direct that in the Construction and Operation of Engineering Works Bye-Laws, 1987, the following further amendments shall be made, namely:—

In the aforesaid Bye-laws,-

- (1) in bye-law 2, after clause (m), the following new clause shall be inserted, namely:—
 - "(ma) "trainee engineer" means engineering graduates, graduated and subsequently registered with the Council as registered engineer during last two years from the date of submission of application by the constructors or operators for the registration, renewal, up-gradation and down-gradation etc. of their firms, companies and licences.; and
 - (2) in bye-law 4, in sub-bye-law (7), for Table 'A', Table B', Table 'C' and Table 'D', the following shall be substituted, namely:—

- (a) If a foreign firm in JV with Pakistani firm has not obtained any work with "provisional licence", it shall have to apply for renewal of "provisional licence" after its expiry, till the firm obtains any project or work in JV with Pakistani firm of appropriate category.
- (b) Each "provisional licence" shall (in watermark and bold) carry remarks "Only for Bidding".;

- (3) in bye-law 7, for sub-bye-law (2), the following shall be substituted, namely:—
 - "(2) Foreign constructor or operator shall be eligible to work with Pakistani constructor or operator, even if the technology is available in Pakistan. The Council may issue licence to foreign constructor or operator on yearly basis which may be renewed after its expiry. The foreign constructor or operator may apply for issuance of provisional licence subject to fulfillment of conditions as set out in Table 'C' and 'D', which shall be valid only for participation in the bidding. Foreign firm shall not be eligible to participate in bidding individually and shall enter into joint venture with Pakistani firm registered with the Council in equivalent and compatible category and submit the same to the employer before participating in bidding. In the establishment of a joint venture, the share of Pakistani constructor or operator shall not be less than thirty percent. After awarding of work, it is mandatory for the foreign constructor or operator to obtain standard licence to undertake the project for which compliance of conditions as set out in Table 'C' and 'D' .".
