PAKISTAN ENGINEERING COUNCIL

23rd ENGINEERING PRACTICE EXAMINATION (SPRING-2024)

Pakistan Engineering Council under the provisions of PEC Act, 1976 and PDE Byelaws-2008, is holding 23rd Engineering Practice Examination (EPE) for Registered Engineers (REs) who are eligible to apply for the prestigious title of Professional Engineer (PE). The exam will be held simultaneously in the following proposed Cities on **Sunday April 28, 2024**:

As per PEC Act 1976, the "PE" has privilege over "RE" in terms of technical sanction authority, design/ process certification, and preference for higher levels leading towards international practice. All those REs registered with PEC, who meet the following minimum eligibility criteria are eligible to apply:

- Graduated on or after 15th January 2008.
- 5 years of practical experience in relevant field of engineering since registration with PEC till closing date of submission of applications.
- 17 CPD points (Maximum 10 CPD points from work/ job experience and 07 CPD points from other categories of CPD).

The candidates who have already appeared in any previous EPE exams i.e., 20th, 21st and 22nd EPE but could not qualify any one part, can also apply to re-appear in the NOT QUALIFIED part.

Registered Engineers (REs) fulfilling the above eligibility criteria may apply through the Link (<https://cpd.pec.org.pk/EPECustom>). Exam format, EPE syllabi, study material and necessary guidelines are available on PEC website under CPD link (<https://pec.org.pk/cpd/engineering-practice-examination/>). Prescribed EPE fee of Rs. 5,000 + Bank Charges (for both parts) and Rs. 2,500 + Bank Charges (for single part) may be deposited in PEC HBLA/c No. 00427901578603 (Branch Code: 0602) by **18th March 2024**.

Note: It is important to mention that Computer Based 23rd EPE will be conducted initially at Islamabad and Rawalpindi Centres only. The candidates who select these centres, will attempt this exam through Computer. All candidates have the option to select Paper Based EPE in other EPE centres.
