2. The subject matter was placed in PEC Engineering Accreditation Board (EAB) in its 117th meeting held on March 20, 2025 and the decision taken by the Board is reproduced below:

"After Deliberation, the EAB decided that the HEIs in the geographical location of Sindh are allowed to adopt the subject of 'Introduction to cooperative Housing Society' as a non-credit course in undergraduate engineering program, in the light of Honorable Sindh High Court Order in C.P No. 1526 of 2026 & C.P No. D-3503 of 2023."


