The PEC Governing Body in its 47th meeting held on September 30, 2023 deliberated on Article 5 (b) of PEC Regulations for Engineering Education in Pakistan to review the decision of 40th Meeting of Governing Body for relaxation in the duration to complete engineering degrees in more than seven (07) academic years till December 31, 2023 due to the ending of their semester in January, 2024 or onwards before the start of Spring-2024 semester in respective HEIs. On the directives of PEC Governing Body, the same was deliberated in EAB in its 112th meeting held on December 20, 2023, and the recommendations endorsed by Vice Chancellors Committee were placed in 48th meeting of PEC Governing Body held on December 30, 2023 for endorsement.

2. The decision is reproduced as below:

"The House approved the proposal to relax the cut-of-date i.e. December 31, 2023 in order to cover the students enrolled upto Fall-2023 semester only".

In light of above, the students, who could not complete their degree in seven academic years and are registered/ enrolled by HEIs till Fall-2023 may be allowed to complete it till the end of Fall-2023 semester (relaxing the cut-of-date of December 31, 2023) and will be considered for registration by PEC.
