Subject: Submission of Student Enrollment Data on SIS Portal

Dear Sir/ Madam.

Pakistan Engineering Council (PEC), being the statutory body established under the PEC Act, 1976, is mandated to regulate the engineering profession and to ensure the maintenance of standards in engineering education across the country. In line with its vision for digital transformation and transparency, PEC has been progressively upgrading its digital platforms to facilitate Higher Education Institutions (HEIs), streamline accreditation processes, and strengthen the linkage between academia and the profession. The Student Information System (SIS) Portal serves as a central repository for verified student data, enabling improved policy decisions, monitoring, and seamless integration with PEC graduate registration framework.

In accordance with the policy approved by the PEC Governing Body, all HEIs are required to submit student enrollment data through the PEC SIS Portal, initially within one month of admission and the final data before the conclusion of the first semester. Under the vision of Engr. Waseem Nazir, Chairman PEC, the Flagship Initiative of "Pathway to Practice", the SIS Portal has been deployed to integrate and streamline the student enrollment data.

This upgraded platform serves as a key enabler to ensure that every eligible engineering graduate is efficiently registered with PEC upon completion of degree, thereby facilitating smooth induction into the PEC initiatives such as **Graduate Engineers Trainee (GET) Program**. The intended objective is to equip fresh engineering graduates with practical, hands-on exposure through involvement in nation-building projects and public service initiatives, strengthen their professional competence and employability through structured mentoring & guided deployment, and foster a collaborative mechanism between PEC & Provincial Governments, National Building Departments/ Organizations to enhance engineering capacity across the country.

The timely submission of data by your HEI will facilitate efficient verification, minimize administrative backlog, and enable PEC to extend registration of graduates seamlessly.

In this regard, it is requested to ensure the submission of requisite data for Intake Batches 2022 and onward on the SIS Portal (https://accrd.pec.org.pk/web/login) at the earliest, in order to comply with PEC regulatory requirements.
